Subject: "The Jab" and Professional Ethics

I am Chaplain Rob Sugg. I am a retired USAF Chaplain having served as enlisted and officer between 1978 and 2014. I have two masters' degrees and have been published in military journals including Air & Space Power, Armed Forces Journal and Military Chaplain.

Having researched the origins and transmission of COVID; the nature and delivery of the experimental vaccine; and fielding numerous questions and concerns from active and retired military; I offer you the following:

FACTS:

1. COVID-19 almost certainly originated in a Chinese Communist Party (CCP) weapons lab.
2. Upon release of the virus, the CCP restricted only *inbound* flights from Wuhan.
3. Immediately upon COVID arrival in the US, all billionaire-owned corporate media began a 24-7 coordinated campaign of terror and lies while all corporate social media outlets "canceled" and blacklisted all opposing voices.
4. The World Health Organization is controlled by the Chinese Communist Party and informs the National Institute of Health and the Centers for Disease Control.
5. In *spite of clear science to the contrary*, our most senior military leaders exclusively defer to these "experts" to mandate DoD policy. Why?
6. There is not a single scientific study that supports public masking and a dozen that say it is a very bad idea.
7. The experimental vaccine has *officially* killed tens of thousands of Americans and injured or maimed an additional 400,000. Both Moderna and Pfizer destroyed their control groups following the initial testing. There are no long term studies. We are the experiment.
8. The COVID-19 survival rate for the average service member is 99.986% without available and inexpensive prehospital treatment.
9. The antivirals Hydroxychloroquine and Ivermectin provide excellent prophylaxis and treatment for COVID and are safer than Tylenol.
10. Having the COVID infection provides a robust and lasting immunity with no need for a vaccine.
11. The DoD stock of vaccines is *still* under Emergency Use Authorization (EUA), is *still* classified as *experimental*, and is *still* legally distinct from an FDA licensed vaccine that has not been manufactured. <https://www.fda.gov/media/150386/download>.

The FDA guidance document Emergency Use Authorization of Medical Products and Related Authorities states: “For an unapproved product and for an unapproved use of an approved product, the statute requires that FDA ensure that recipients are informed to the extent practicable given the applicable circumstances” and “That they have the option to accept or refuse the EUA product and of any consequences of refusing administration of the product...” • <https://www.fda.gov/regulatory-information/search-fda-guidance-documents/emergency-use-aut horization-medical-products-and-related-authorities>.

The truth of these statements is readily available to anyone who shuns corporate media and looks at original sources. Every senior medical officer must know these facts or is grossly negligent. Likewise, senior JAGs are well aware that the vaccine is still experimental and is governed by both federal statute and the Nuremberg Code. Junior JAGs are sitting in silence.
